These are relatively affordable alternatives that house together companies in technology and research-oriented industries. For example, one-north is a 200-hectare development housing companies in key growth sectors including biomedical services, infocommunications technology and engineering industries.

B2 Industrial: B2 properties are suitable for businesses with heavier manufacturing and production activities. B2 industrial properties are usually located further away from residential areas due to the noise and/or air pollution generated by heavy production activities.

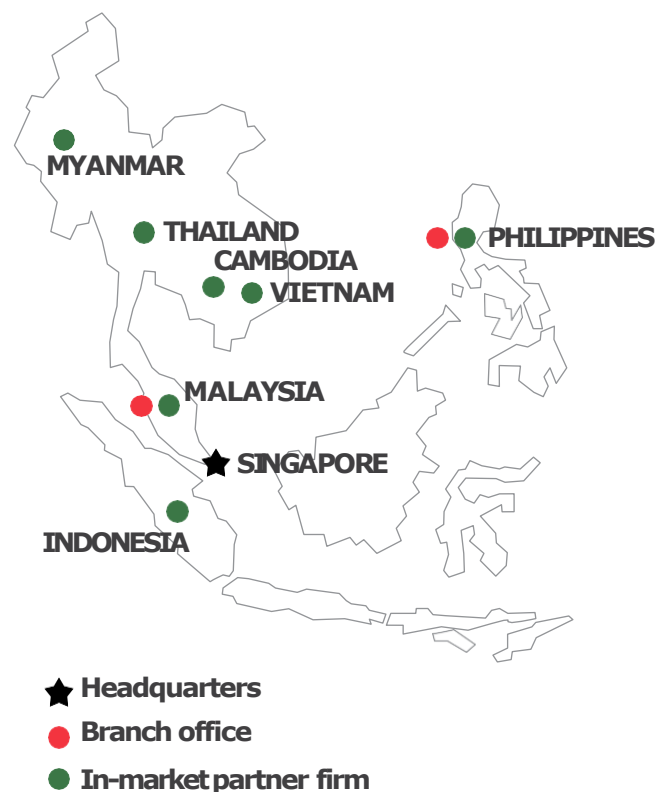

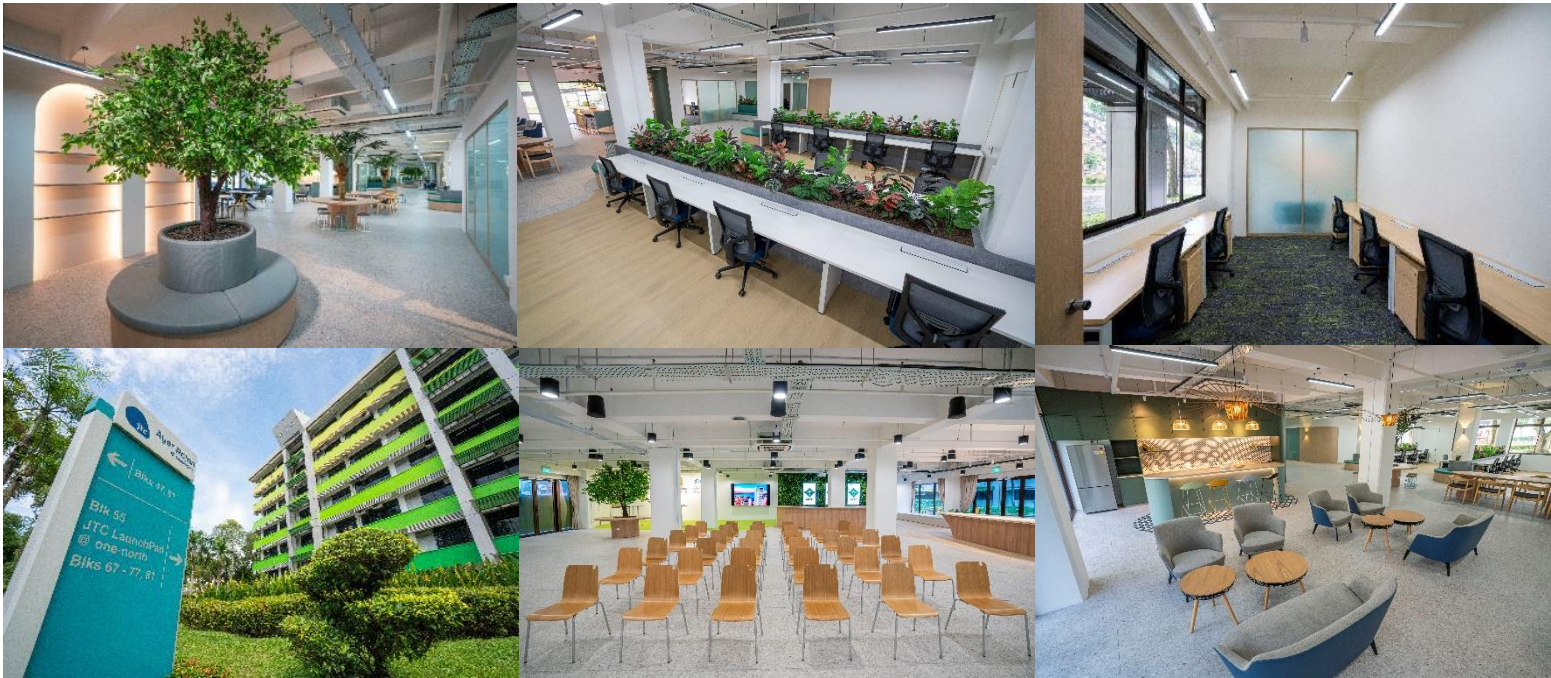

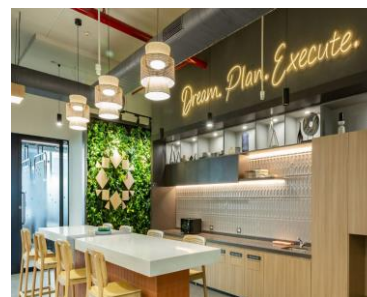
